- A university degree as listed below is requested. Applicants should hold, or anticipate to receive it not later than 6 months after deadline. If you have not yet finished your course we need a provisional certificate or statement of marks by your university about your accomplishments so far.
- Candidates from countries not listed should hold a recognised degree that enables them to enter a PhD program in their own country. The evaluation panel may decide whether or not your degree is suitable for entering the PhD program Infection Biology.
